It is very pleasure to share our happiness that the Tadipatri Municipality got 5<sup>th</sup> place in property tax collections with 97% for the financial year 2016-17 ended by 31<sup>st</sup> March 2017. From last five years the ULB has achieved 95% and above collections with the public support.

The State Election Commission, Andhra Pradesh, Hyderabad has issued Casual Election Notification for 4<sup>th</sup> and 6<sup>th</sup> wards of Municipal Council, Tadipatri which were vacant from last two years. ## DESTROYING CARBIDE FRUITS:

Calcium carbide fruits cause various health hazards like, headache, dizziness, sleepiness, memory loss, cerebral edema and seizures. These results indicate that fruit treatment with calcium salts not only affects the ripening process



but also influences the aroma of the fruits. The Hon'ble High Court has given directions to the Government to take severe action on selling of Carbide ripening fruits.



Tadipatri Town is famous for free Carbide fruits from last decade, all fruits must be sold by naturally ripening. Efforts are being taken to strict implementation of ban on selling of carbide fruits. If noticed any violation, severe action has been initiated

against the sellers. Recently, an incident was noticed on selling of carbide mangoes, the ULB staff has initiated action by tactical drill with tractor, and strictly warned all the fruit vendors in the Town for not selling of carbide fruits.

## **PULSE POLIO IMMUNIZATION PROGRAMME-2<sup>nd</sup> ROUND:**

The second round pulse polio programme is scheduled from 02-04-2017 to 04-04-2017. Oral polio vaccine will be administered to about 9000 children below five years of age in the Town in second phase pulse polio programme, to prevent any chances of the resurgence of polio transmission due to wild polio virus.



In view of the above, rally was conducted in the town with officials of Health Department, Anganwadi, NGOs and other stakeholders to create awareness among the public about Pulse polio immunization programme.

## **5<sup>th</sup> PLACE IN PROPERTY TAX COLLECTIONS for 2016-17**

The financial year 2016-17 will be closed by 31<sup>st</sup> of March 2017. In order to achieve 100% collection of Taxes and Non-taxes, the ULB has intensified special efforts by conducting special drives involving all field and other officials headed by Revenue Officer. So many initiative steps like mike announcements, Local cable TV scrolling, direct contact of top 100 defaulters in each ward are taken and also arranged special counters to avoid rush and in convenient to the tax payers, also special focus on dull tax payers. The citizens are responding and paid taxes promptly. Resulting, the Tadipatri Town stood 5<sup>th</sup> place in 110 ULBs in the State with 97% of collection of property tax by end of financial year.
