**General Technical Terms and Conditions (Procedure)**

1 The participating bidders have to pay transaction fee as per G.O.Ms.No. 13 dated. 5.7.2006 ,permitting integration of electronic Payment Gateway of ICICI/HDFC Banks with apeProcurement platform, which provides a facility to participating suppliers/contractors to electronically pay the transaction fee from the platform, using their credit cards.The Payment Gateway accepts all Master and VISA credit cards issued by any bank to conduct the transaction. 2 The Contractor should upload the scanned copies of (i) Required Registration Class of Contract. (ii) Total monetary value of civil construction works performed for each financial year for the last five years with certificates from the concerned officer of the rank of Executive Engineer (PR) or equivalent and counter signed by the SE. iii) Experience in works of a similar nature and size for each of last five years issued by Executive Engineer or equivalent and counter signed by the SE. iv) Details of works in progress or contractually committed with certificates from the concerned officer of the rank of Executive Engineer . v) Attested copy of Permanent Account Number (PAN) card along with latest Saral Form in support of the submission of IT returns ( AY 2015-16). (vi) Copy of VAT Registration Certificate along with TIN No. obtained from Commercial Tax Department after 02-06-2014 along with latest valid commercial tax clearance certificate. (vii) Proof of evidence of access to lines of credit and availability of other financial resources facilities or solvency certified by banker the certificate being not more than 12 months old for required amount (viii) Report on the financial standing of the bidder such as profit/loss statements for past three years.( Optional) (ix) Evidence of ownership of major item of construction equipment on NJ Stamp of Worth Rs 100/- ( Self Declaration )as shown in document (or) evidence of possessing them on hire/leases/buying as defined in document.( The leased Agreement between Owner and

All the uploaded documents and certificates shall be signed by the tenderer duly stating that the details furnished are correct. 4 Each tenderer must pay along with tender a sum of amount @ 1% of ECV as EMD in the shape of crossed DD/BG obtained from any Scheduled Commercial Bank/Nationalised bank valid for Three (3) months from date of Notice inviting tenders and should be scanned and uploaded along with the bid. 5 The successful (L1) tenderer shall furnish the original hard copies of all the documents/certificates/statements uploaded by him before concluding agreement. 6 e-Procurement Corpus fund @ 0.04% administered by A.P.T.S has to be paid by the successful bidder in favour of MD, APTS, Hyderabad at the time of concluding the agreement. 7 The successful tenderer has to sign an agreement with in a period of 10 days from the date of receipt of communication of acceptance of his tender. On failure to do so, his tender will be cancelled duly forfeiting the E.M.D paid by him without issuing any further notice. 8 The Successful bidder has to pay 2.5% of TCV/ECV towards performance security i.e., 2.5 % at the time of concluding agreement and remaining 5% will be retained of each payment due to the contractor until completion of whole of the construction work 1% EMD paid at the time of tender will be returned after concluding the agreement. 9 Tenders shall be valid for a period of 90 days. The bidder shall submit his response through Bid submission to the tender on eProcurement platform at [www.apecurement.gov.in](http://www.apecurement.gov.in) by following the procedure given below. The bidder would be required to register on the e-procurement market place [www.apecurement.gov.in](http://www.apecurement.gov.in) or <https://tender.apecurement.gov.in> and submit their bids online. Offline bids shall not be entertained by the Tender Inviting Authority for the tenders published in eprocurement platform. The bidders shall submit their eligibility and qualification details, Technical bid, Financial bid etc., in the online standard formats displayed in apecurement web site. The bidders shall upload the scanned copies of all the relevant certificates, documents etc., in support of their eligibility criteria/technical bids and other certificate/documents in the eProcurement web site. The bidder shall sign on the statements, documents, certificates, uploaded by him, owning responsibility for their correctness/authenticity. The bidder shall attach all the required documents for the specific tender after uploading the same during the bid submission as per the tender notice and bid document. 1. Registration with apecurement platform: For registration and online bid submission bidders may contact HELP DESK. G.O.Ms.No.174, I&CAD dept dated:1-9-2008, submission of original hard copies of the uploaded scanned

copies of DD/BG towards EMD by participating bidders to the tender inviting authority before the opening of the price bid is dispensed forthwith. ii) All the bidders shall invariably upload the scanned copies of DD/BG in eProcurement system and this will be the primary requirement to consider the bid responsive. iii) The department shall carry out the technical evaluation solely based on the uploaded certificates/documents, DD/BG towards EMD in the eProcurement system and open the price bids of the responsive bidders. iv) The department will notify the successful bidder for submission of original hardcopies of all the uploaded documents DD/BG towards EMD prior to entering into agreement. v) The successful bidder shall invariably furnish the original DD/BG towards EMD, Certificates/Documents of the uploaded scan copies to the Tender Inviting Authority before entering into agreement, either personally or through courier or post and the receipt of the same within the stipulated date shall be the responsibility of the successful bidder. Ms. No. 174 -I&CAD dated: 1-9-2008 Deactivation of Bidders If any successful bidder fails to submit the original hard copies of uploaded certificates/documents, DD/BG towards EMD within stipulated time or if any variation is noticed between the uploaded documents and the hardcopies submitted by the bidder, as the successful bidder will be suspended from participating in the tenders on eProcurement platform for a period of 3 years. The eProcurement system would deactivate the user ID of such defaulting bidder based on the trigger/recommendation by the Tender Inviting Authority in the system. Corpus Fund: As per GO MS No.4 User departments shall collect 0.04% of ECV (estimated contract value) with a cap of Rs.10,000 (Rupees ten thousand only) for all works with ECV upto Rs.50 Crores, and Rs.25,000/- (Rupees twenty five thousand only) for works with ECV above Rs.50 Crores, from successful bidders on eProcurement platform before entering into agreement / issue of purchase orders, towards eprocurement fund in favour of Managing Director, APTS. There shall not be any charge towards eProcurement fund in case of works, goods and services with ECV less than and upto Rs. 10 lakhs 7. Tender Document: The bidder is requested to download the tender document and read all the terms and conditions mentioned in the tender Document and seek clarification if any from the Tender Inviting Authority. Any offline bid submission clause in the tender document could be neglected. The bidder has to keep track of any changes by viewing the Addendum/Corrigenda issued by the Tender Inviting Authority on time-to- time basis in the E-Procurement platform.
